TREASURERS REPORT 2012

I report that the District operated with a larger than expected deficit of \$2,413 against the budgeted shortfall of \$1,383 – As you can see from the Receipts/Expenses statement, there were some ups & downs, specifically I would like to highlight the fact that the amount expended on Trophies/Balls & the Affiliation Fee amounted to \$8,315 which is 65% of your annual subscriptions. Also the premium for Insurances taken out during the year at a cost of \$2,645 was an unbudgeted item and with these factors in mind the years results are considered acceptable.

I would like to thank Stewart Ley our Secretary for the time and effort put into the District, also thanks to Kevin Milner as our Webmaster – his expertise in computers is of great advantage to our Membership and his overseeing of the current complete new website is very much appreciated. My thanks also to the members of the Operations Team and to Robin George for assisting with the cash on game days (when he is on the desk).

I would also like to add my personal appreciation for the efforts of all the other Members of your Committee and would like to take the opportunity to thank the retiring members Robin George, Ian Hughes & David Teasdale for their contributions to Committee and welcome the incoming members Bruce Ayres, Peter Barber & David Schreiber.

I have pleasure in presenting these accounts to the Membership and would propose that the Audited accounts as presented be approved and in accordance with our Constitution that the continuance of our current annual fees of \$30 (with a rebate of \$5 to those Members who have attained the age of 70 and have completed five years of membership) and also the continuance of the nomination fee of \$70 be approved.



Our Constitution has been in existence since inception in 1983 and your Committee felt that it required review to bring it up to date to represent the District in 2012 & the future. Basically there have been a few cosmetic type changes—omission of "District" from the original "heading" page and also a grammatical change.

Other changes were related to the definition of "Veteran Golfer", redefining membership categories to include Honorary Members for Life and non playing members, Privacy concerns re the Register of Members, Annual collection of fees timings, Notices to Members, Election Procedure and a complete update of the membership Application form. These proposals are detailed hereunder and Members are advised that a "marked up" copy of the Constitution incorporating the proposed amendments is available for perusal—this will be held by the Secretary and will be made available for perusal at games or by arrangement. A marked up copy will also be placed on the Website.
